Following our review of the record, we conclude that the director had reasonable grounds to find that the youth court would have been able to provide its services and care as effectively as the tribal court. The record shows that the tribal court provides a rehabilitation program for juveniles in the Alkali Flats region and that the ASB offers therapy to promote sobriety. The state does not question the Alkali Flats court's jurisdiction to decide whether a juvenile should be declared to be a ward of the tribal court and made a part of the tribe's jurisdiction. The state argues only that the director's finding was not based on evidence of where the Alkali Flats court would have placed the minor and whether the ASB is an appropriate placement for the minor. However, the record contains substantial evidence of the availability of the Alkali Flats court's services and the suitability of the ASB. The district court thus did not err by refusing to follow the director's conclusion that the youth court would not have been an appropriate placement. The director also could have reasonably found that the Alkali Flats court could have responded to the minor's need for services in a manner as effective as the tribal court
